

## **Public Offer on the Conclusion of a Donation Agreement**

### **1. GENERAL PROVISIONS**

1.1. This public offer (hereinafter referred to as the "Offer") is an offer of the "Welcome KG" Public Foundation (hereinafter referred to as the "Foundation") to conclude the donation agreement (hereinafter referred to as the "Agreement"), with any citizen of the Kyrgyz Republic, a citizen of another state or a legal entity which responds to the Offer (hereinafter referred to as the "Donor") on the terms and conditions provided below.

1.2. The Offer is addressed to an unlimited circle of persons.

1.3. The Offer is a public offer in accordance with the Article 396 of the Civil Code of the Kyrgyz Republic.

1.4. The Offer comes into force from the day it is posted on the Foundation's website on the Internet at [www.wclkg.org](http://www.wclkg.org) (hereinafter referred to as the "Website").

1.5. The Offer is valid indefinitely. The Foundation has the right to cancel the Offer at any time without giving reasons. The Offer may be amended and supplemented, which come into force on the day following the day of its placement on the Website. The invalidity of one or more terms of the Offer does not entail the invalidity of all other terms of the Offer.

1.6. The placement of the Offer and the place of conclusion of the Agreement is the city of Bishkek, the Kyrgyz Republic.

1.7. This Offer is governed by and construed in accordance with the laws of the Kyrgyz Republic.

1.8. By agreeing to the Offer Agreement, the Donor gives his/her consent to the processing of the data specified by him/her and agrees to receive newsletters from the Foundation, which s/he can refuse at any time.

### **2. TERMS OF THE AGREEMENT**

2.1. The Donor transfers funds free of charge to the Foundation in the amount determined by the Donor for the purposes specified in clause 2.2 of the Offer.

2.2. Purpose of the donation: Providing charitable assistance for the development of the Women's Creative Laboratory implies and means the financing of programs / projects implemented by the Foundation for the Development of Women's Entrepreneurship and Increasing the Level of Women's Economic Employment. When making a donation, the Donor agrees with the purpose of the payment, accepts, and shares the goals and objectives of the Foundation's projects and programs.

2.3. The procedure for concluding the Agreement:

2.3.1. The Agreement is concluded by accepting the Offer by the Donor.

2.3.2. The Offer can be accepted by the Donor by transferring his/her funds (hereinafter referred to as "Donation") in favor of the Foundation using the details specified in section 3 of the Offer, indicating as the purpose of payment:

***“Providing charitable assistance for the development of the Women’s Creative Laboratory.”***

2.3.3. The Donor’s action to donate to the Foundation account is considered as an acceptance of the Offer in accordance with Article 399 of the Civil Code of the Kyrgyz Republic.

2.3.4. The date of the Offer acceptance and, accordingly, the date of the Agreement conclusion is the date of funds’ receipt from the Donor to the Foundation account.

2.3.5. Funds contributed by the Donor as charitable assistance are transferred to the Foundation minus the commission due to a third-party intermediary (bank or payment system) that transfers funds.

2.4. Other conditions:

2.4.1. The Foundation has the right to refuse the Donation at any time within 15 working days before and after the transfer of the Donation by the Donor. In case of Donation refusal after the Donation transfer, the Foundation returns the Donation within 7 working days after the decision to refuse is made. In this case, this Agreement is considered terminated from the moment the Foundation decides to refuse. If it is impossible to transfer the Donation to the Donor, the Donation remains at the disposal of the Foundation.

2.4.2. By performing the actions provided for by this Offer, the Donor confirms that s/he is familiar with the terms and text of this Offer, the goals of the Foundation, is aware of the significance of his/her actions, has the full right to perform them and fully accepts the terms of this Offer.

2.4.3. In accordance with the Law of the Kyrgyz Republic “On Personal Information,” the Donor hereby gives his/her consent to the processing of his/her personal data by any means not prohibited by law for the purposes of executing this Agreement.

2.4.4. The Donor hereby confirms that at the time of the Offer acceptance, s/he acts on his/her own behalf, at his/her own expense and in his/her own interest. The Donor confirms that s/he is not under the influence of delusion, deceit, or violence.

2.4.5. In cases where, in the opinion of the Donor, an erroneous transfer of charitable assistance to the Foundation is made, the cancellation of such a transaction is carried out in court, in accordance with Article 514 of the Civil Code of the Kyrgyz Republic.

2.4.6. In cases of disputes between the Donor and the Foundation, such a dispute is subject to resolution in the International Arbitration Court at the Chamber of Commerce and Industry of the Kyrgyz Republic (hereinafter referred to as “IAC CCI”) in accordance with the Rules of the IAC CCI by one arbitrator elected in accordance with the Rules of the IAC CCI. The applicable substantive law, in accordance with which the dispute will be considered, is the legislation of the Kyrgyz Republic. Arbitration proceedings must be conducted in Russian. The decision of the Arbitration Court is final for the parties.
